

Office of Child Care (OCC) Compliance Announcements Frequently Asked Questions (FAQs)

1. If staff complete the Better Kid Care, *Get Started with Center-based Care: Building Blocks for Quality* (K6.2, C1, CDA6; 10 hours), does it count towards the required Pre-Service training?

Yes, here are the Better Kid Care (BKC) Pre-Service modules in English and Spanish titles for the pre-service courses:

- Center/Group Child Care Homes (GCCHs):

NOTE: These free Better Kid Care modules replaced *Health and Safety Basics: Requirements for Certification* course on July 1, 2018. Any completion of the *Health and Safety Basics: Requirements for Certification* course after June 30, 2018, does not count toward the new Health and Safety Professional Development (PD) requirement and is also no longer free to take. 2. Do all child care staff currently working in a certified child care program need all the PD trainings by April 29, 2022?

Yes, all child care staff **must** complete PD trainings (also known as Pre-Service Training in [Announcement C-22-02](#)) within 90 days of hire.

Current child care staff who have completed the entire Pre-Service training, ([Get Started with Center-Based Care: Building Blocks for Quality \(PA residents only\)](#) or [Get Started with Home-Based Care: Building Blocks for Quality \(PA residents only\)](#) course after June 30, 2018 or *Health and Safety Basics: Requirements for Certification* prior to June 30, 2018) have completed the trainings needed to care for children unsupervised and **no additional Pre-Service training is needed.**

OCDEL recommends new child care staff complete the BKC Pre-Service training modules as the quickest and easiest way to meet the Pre-Service training requirement.

For new child care staff still within their 90-day new hire window, the following six (6) required health and safety training topics **must** be completed before a child care staff can care for children unsupervised:

- Pediatric First Aid & Pediatric Cardiopulmonary Resuscitation (CPR);
- Prevention of Sudden Infant Death Syndrome (SIDS) & Use of Safe Sleep Practices;
- Prevention and Control of Infectious Diseases (including immunizations);
- Prevention of and Response to Emergencies due to Food and Allergic Reactions;
- Prevention of Shaken Baby Syndrome, Abusive Head Trauma, and Child Maltreatment; and
- Recognition and Reporting of Child Abuse and Neglect (Mandated Reporter Training).

Child care staff **do not** need to duplicate the six (6) above trainings as those will count towards the Pre-Service health and safety training topics. The child care staff are still required to take the remaining five (5) health and safety topics within the 90 days of hire, which include the following:

- Administration of Medication, consistent with standards for parental consent
- Building and Physical Premises Safety, including Identification of and Protection from Hazards, Bodies of Water and Vehicular Traffic
- Emergency preparedness and response planning for emergencies resulting from a natural disaster, or a man-caused event (such as violence at a child care facility), within the meaning of those terms under section 602(a)(1) of the Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C. 5195a(a)(1)) that shall include procedures for evacuation, relocation, shelter-in-place and lock down, staff and volunteer emergency preparedness training and practice drills, communication and reunification with families, continuity of operations, and accommodation of infants and toddlers, children with disabilities, and children with chronic medical conditions
- Handling and Storage of Hazardous Materials and the Appropriate Disposal of Bio-contaminants
- Appropriate precautions in Transporting Children

All child care staff in a certified child care program **must** complete an annual minimum of 12 clock hours of child care PD training. Child care staff hired on or before December 19, 2020, will use that date as their anniversary date to assess compliance with annual minimum of 12 clock hours of child care PD training. Child care staff hired after December 19, 2020, will use their actual hire date to assess compliance with annual minimum of 12 clock hours of child care PD training.

3. [Can the compliance date of April 29, 2022, for these new certification requirements be extended?](#)

The information issued in Announcements [C-22-01](#), [C-22-02](#), and [C-22-03](#) are **not** all new requirements. In order to provide clarification, an updated [Health and Safety Training Certification Requirements: OCDEL Guidance Chart can be viewed here](#). The new requirements for each announcement include, but are not limited to:

- **Announcement C-22-01:** The Pediatric First Aid and Pediatric CPR training **must be conducted by an approved Pennsylvania Quality Assurance System (PQAS) Instructor** using an OCDEL recognized PQAS curriculum.
 - **Completion by Apr. 29, 2022.**
- **Announcement C-22-02:** The required health and safety training topics that **must** be completed before a child care staff can care for children unsupervised.
 - **Completion by Apr. 29, 2022.**
- **Announcement C-22-03:** All Department of Human Services DHS certified child care providers **must** have a policy and procedure to identify the prevention of shaken baby syndrome, abusive head trauma, and child maltreatment. The policy must include, but is not limited to:
 - Recognition of potential signs and symptoms of shaken baby syndrome and abusive head trauma;
 - Strategies for coping with a crying, fussing, or distraught child; and
 - Address the prevention and identification of child maltreatment.
 - **Completion by April 29, 2022**

4. There is a cost to training, including not only the cost of the training, but the need to pay new staff (or existing staff) to take (or update) the training. This is an operating budget item as well as an administrative challenge during these times with staff recruitment and retention issues. Programs are short staffed and would need to pay staff to do PD in the evening or weekend since they cannot leave classroom when needed to maintain compliance with staff:child ratio. Can OCDEL waive the cost for the required PD trainings?

Many of the mandatory Pre-Service trainings are offered a little or no cost. OCDEL recognizes the employee related costs related to time and substitute coverage and encourages child care operators to consider using funds available through the current ARPA Stabilization grants or other stimulus funds to offset some or all of these costs.

Keep Kids Safe provides Recognition and Reporting of Child Abuse and Neglect (Mandated Reporter Training) at [mandated reporter training at no cost to providers](#). Additional training options include: [PA Child Welfare Resource Center](#) and [Pa Family Support Alliance](#). Keep Kids Safe offers a list of additional approved courses for child abuse recognition and reporter training.

Better Kid Care (BKC) provides the 10-hour Pre-Service training, on behalf of OCDEL, at **no cost** to providers:

5. The cost of Pediatric First Aid/CPR varies by agency. Does OCDEL provide any free Pediatric CPR/First Aid Trainings for certified child care providers and staff?

Early Childhood Education Professional Development Organizations (ECE PDOs) provide access to free, Pennsylvania Quality Assurance System (PQAS) approved, [Pediatric First Aid and Pediatric CPR training](#). The ECE PDOs contact information can be found [here](#). OCDEL is also working with other community-based organizations to expand free Pediatric First Aid and CPR offerings.

6. With the current level of staff turnover, is it necessary to have a PQAS approved Pediatric First Aid/CPR instructor available?

Yes, effective April 29, 2022, all Pediatric First Aid and Pediatric CPR training **must** be conducted by an approved PQAS Instructor using an OCDEL recognized PQAS curriculum. Instructions on how to become a PQAS approved instructor can be found [here](#).

7. Trainings on the PD Registry are different number of hours for the same topics, what is the hour requirement for each topic area? Certified child care programs are worried they will spend time and money training staff and it won't be accepted, leading to having to spend even more time and money.

Within the annual minimum 12 clock hour PD training requirement, it is at the program's discretion as to how they would like to address which health and safety PD training topics staff obtain. With the exception of Pre-Service Training, an approved Mandated Reporter training, and Pediatric First Aid and Pediatric CPR the focus is on the health and safety topics as opposed the number of hours per training.

As long as the child care staff has a total of at least 12 clock hours in PD training annually, DHS certification staff are **not** determining compliance on how many hours each course/training was.

As a reminder, the required Pre-Service training can be used only **once** toward the annual minimum 12 clock hours. Pediatric First Aid & Pediatric Cardiopulmonary Resuscitation (CPR) and Recognition and Reporting of Child Abuse and Neglect (Mandated Reporter Training) **can also count** towards the annual minimum 12 clock hours based on the renewal of the training certificate. If child care staff want to include any of these trainings as a part of their annual minimum 12 clock hours, then documentation of training hours **must** be included for verification by DHS certification staff.

8. Does a new hire who has documentation of Pre-Service completion at a prior employer need to retake the Pre-Service Training as a new hire in my facility?

The PD Registry maintains a transcript of all PD taken through the registry. If the individual has documentation of previous Pre-Service completion and is current on both the Pediatric First Aid/Pediatric CPR and Mandated Reporter training, they have fulfilled these requirements.

9. Will these trainings need to be renewed every year or every "x" number of years, or are they once and done?

All child care staff **must** complete a minimum of 12 clock hours of training annually. The required Pre-Service training is a once and done training and can count **once** toward the annual minimum 12 clock hours. Pediatric First Aid & Pediatric Cardiopulmonary Resuscitation (CPR) **must** be renewed according to the timing of the approved Pediatric First Aid and Pediatric CPR model, which is usually **every two (2) years**. Recognition and Reporting of Child Abuse and Neglect (Mandated Reporter Training) must be renewed **at least every five (5) years**. Both can also count towards the annual minimum 12 clock hours based on the renewal of the training certificate. If child care staff want to include any of these trainings as a part of their annual minimum 12 clock hours, then documentation of training hours **must** be included for verification by DHS certification staff.

10. Do the required 12 hours of annual training ALL need to be health & safety related?

No, it is at the program's discretion as to how they would like to address which health and safety PD training topics staff obtain annually.

11. There needs to be clarification regarding what is required hours for Certification and Keystone STARS. Does required health and safety trainings count for Keystone STARS?

All child care providers with a regular certificate of compliance issued by DHS and preschool programs licensed by the Pennsylvania Department of Education (PDE) will be awarded a STAR 1 to indicate foundational achievement in meeting health and safety standards. Programs may choose to participate in

ongoing quality improvement activities to move to higher STAR levels. Keystone STARS includes standards related to ongoing PD based on advance staff qualifications or fulfilling individual PD plans. OCDEL has adopted the Pennsylvania Professional Standards and Competencies for Early Childhood Educators (PA PSCECE) to guide ongoing PD. Some ongoing PD in health and safety topics may overlap with the Health and Safety Standards in the PA PSCECE section 7. Questions about training as it applies to Keystone Stars should be shared with your STARS Quality coach.

12. Can the ECE PDOs communicate directly with the program administrator or operator?

The ECE PDOs work directly with DHS certified child care staff to offer free and approved Pediatric First Aid and Pediatric CPR training based on the prioritization scheduling outline in [Announcement C-22-01](#). If the program administrator or operator want to be included in the communication that needs to be handled with the DHS child care staff.

13. What are the PQAS approved models for Pediatric First Aid & Pediatric Cardiopulmonary Resuscitation (CPR)?

OCDEL provides an updated list [here](#). Curriculum will continue to be reviewed for approval by the Pennsylvania Key and if others are approved, an updated listing will be provided [here](#).

14. What would the Pre-Service Training outline look like if programs wanted to conduct orientation themselves?

The only acceptable Pre-Service training through Better Kid Care (BKC) which provides the 10-hour Pre-Service training, on behalf of OCDEL, at **no cost** to providers:

15. If a provider may have taken Shaken Baby and Head Trauma training, but it may have been within another Health and Safety PD, will this be acceptable for now? Moving forward would there be separate PD on this topic available online as in the past?

Yes, but providers must be able to offer documentation of these topics if they are included within other training content. All DHS certified child care staff must successfully complete training requirement related to the prevention of shaken baby syndrome, abusive head trauma, and child maltreatment.

OCDEL will notify the child care community of any health and safety PD training updates listed at 55 Pa Code §3270.31(f); §3280.31(f); §3290.31(f), and all child care staff will be required to take the updated PD within a prescribed timeframe.

16. Are there any plans to have the Institutes of Higher Education (IHEs) provide child care staff enrolled in an early childhood education/child development program with the required trainings, so they are completed when they finish their program? Could we add 1 or 2 credit courses for ongoing PD training for existing child care staff who have completed their degree program?

OCDEL's ECE PDOs are working to reduce barriers for the child care professionals, and this is something we can have further conversations with our IHE partner.

17. What if a child care staff completed Pediatric First Aid/CPR training **before April 29, 2022**, but the instructor was not PQAS certified?

Please note the following does not apply to the course titled *“Adult, Child, and Baby First Aid/CPR.”*

If child care staff have current Pediatric First Aid/CPR training from an approved curriculum, but the instructor is not “PQAS” certified to provide this training, the certification representative will cite, and obtain an acceptable Plan of Correction (POC). If the owner/operator is able to complete one or more of the following within the first 30 days of the acceptable POC, they should follow up with their certification representative:

- Request and provide documentation that the entity which provided Pediatric First Aid/CPR training has submitted documentation to become a PQAS Instructor approved to provide Pediatric First Aid/CPR training. Instructions on how to become a PQAS approved instructor can be found [here](#).
- Request the instructor provide documentation, such as their Pediatric First Aid/CPR Instructor Card, from the PQAS approved organization or the approved curriculum organization, such as American Heart Association (AHA) or American Academy of Pediatrics (AAP), that the instructor is approved to offer Pediatric First Aid/CPR training on behalf of their organization.
- Have the impacted child care staff retake the training with a “PQAS” certified instructor. If the owner/operator chooses to redo the training the certification representative can refer them to the ECE PDOs to complete Pediatric First Aid/CPR training.

If one of the options listed above is completed within the first 30 days of the acceptable POC, the owner/operator should reach out to their certification representative to rescind this specific citation. **Child care staff may care for children unsupervised with an acceptable POC that includes one or more of the above options.**

If the owner/operator cannot resolve corrective action within the first 30 days of the acceptable POC, the owner/operator must comply with timelines approved in their POC to meet the requirement. **Child care staff may care for children unsupervised with an acceptable POC that includes one or more of the above options.**

18. What if child care staff completed Pediatric First Aid/CPR training **after April 29, 2022**, but the instructor was not PQAS certified?

OCDEL issued the policy related to PQAS requirement and approved curriculum on January 11, 2022. After April 29, 2022, only Pediatric First Aid/CPR training delivered by a PQAS approved instructor or training organization, or an entity demonstrating they are in progress to become approved will be accepted.

Child care staff hired after **April 29, 2022**, may **not** care for children unsupervised until the Pediatric First Aid/CPR training is completed by a PQAS approved instructor. Please refer to Question 2 for the required preservice trainings newly hired staff must complete before working unsupervised with children.

19. Will child care facilities have to shut down if their child care staff have not completed the required Pre-Service Trainings?

Not necessarily, the child care facility does not have to shut down if certain child care staff have not completed the required Pre-Service trainings. The certification representative will cite for any child care staff who do not have pre-service training completed within 90 days from date of hire. Until the child care staff completes the required Pre-Service trainings, they cannot care for children unsupervised. Supervision

must be provided by, at minimum, an assistant group supervisor, primary staff person or family child care home operator, who has completed the required health and safety training.

20. Who needs to be included in the annual emergency drills (55 Pa. Code § 3270.27(a)(6); § 3280.26(a)(6); § 3290.24(a)(6))?

All facility persons, including volunteers, **must** be included in the annual emergency drill. A facility person is defined as “a staff person, a substitute staff person, a volunteer, a food service person, a janitorial person or another adult who services in or is employed by a facility.”

Current Staff: If professional development trainings (also known as Pre-Service Training) have already been completed within 90 days of hire, then they can care for children unsupervised.

New Staff: If DHS certified child care staff who are still within 90 days of hire to complete professional development trainings (also known as Pre-Service Training), they need to complete the required professional development trainings before they can care for children unsupervised.

If DHS certified child care staff complete the entire professional development trainings (also known as Pre-Service Training) prior to caring for children unsupervised then that meets this requirement.

The required professional development trainings (also known as Pre-Service Training) include the following Health and Safety topics:

- Prevention and control of infectious diseases (including immunizations)
- Prevention of Sudden Infant Death Syndrome (SIDS) & Use of Safe Sleep Practices
- Administration of Medication, consistent with standards for parental consent
- Prevention of and Response to Emergencies due to Food and Allergic Reactions
- Building and Physical Premises Safety, including Identification of and Protection from Hazards, Bodies of Water and Vehicular Traffic
- Prevention of Shaken Baby Syndrome, Abusive Head Trauma, and Child Maltreatment
- Emergency preparedness and response planning for emergencies resulting from a natural disaster, or a man-caused event (such as violence at a child care facility), within the meaning of those terms under section 602(a)(1) of the Robert T.
